SECTION 3 – HAZARDS IDENTIFICATION

Emergency Overview: This product is a white translucent liquid. It is a mild irritant for eyes. If ingested, it may cause vomiting, headaches and medical problems.

Potential Health Effects:

Eyes: Contact with liquid may cause mild to moderate irritation.
Skin: Prolonged contact with skin can cause mild irritation.
Skin absorption: Prolonged or repeated exposure can cause irritation and drying.
Ingestion: Can cause nausea, vomiting and gastrointestinal irritation.
Chronic Effects:
Skin: Prolonged or repeated exposure can cause drying of skin.

SECTION 4 – FIRST AID MEASURES

Eye: Immediately flush with warm running water for 15 minutes, holding eyelids open during flushing. If irritation persists, repeat flushing and obtain medical attention immediately.
Skin: Immediately flush exposed area with mild soap and water for at least 10 minutes. If irritation persists or if contact has been prolonged, obtain medical attention. Remove contaminated clothing and launder before reuse.
Inhalation: Immediately remove the affected victim to fresh air. If symptoms persist, obtain medical attention.
Ingestion: Do Not Induce Vomiting. If the person is fully conscious, rinse mouth with water and drink a glass of water. Obtain medical attention immediately. Never give anything by mouth if the victim is unconscious, is rapidly losing consciousness or is convulsing.

For large spills, provide diking or other appropriate containment to keep material from spreading. Prevent large spills from entering sewers or waterways.
