SECTION 3 – HAZARDS IDENTIFICATION

Emergency Overview: This product is a white translucent liquid. It is a mild irritant for eyes. If ingested, it may cause vomiting, headaches and medical problems.

Potential Health Effects:

Eyes: Contact with liquid may cause mild to moderate irritation.
Skin: Prolonged contact with skin can cause mild irritation.
Skin absorption: Prolonged or repeated exposure can cause irritation and drying.
Ingestion: Can cause nausea, vomiting and gastrointestinal irritation.
Chronic Effects:
Skin: Prolonged or repeated exposure can cause drying of skin.

SECTION 4 – FIRST AID MEASURES

Ingestion: **Do Not Induce Vomiting.** If the person is fully conscious, rinse mouth with water and drink a glass of water. Obtain medical attention immediately. Never give anything by mouth if the victim is unconscious, is rapidly losing consciousness or is convulsing.

For large spills, provide diking or other appropriate containment to keep material from spreading. Prevent large spills from entering sewers or waterways.
